Comments and interpretation

- Where an MRL column contains no data, the particular data source either does not recognise this as an independent crop type, or no information is available.
- Where an EU harmonised value is indicated, this implies that the EU member and non-member states (Norway and Switzerland) recognise the harmonised level as the import tolerance, except where the non-member states have a higher level, in which case that value applies as an import tolerance (MRL).
- Only PHIs appearing on labels of products registered for use in South Africa are published (data obtained from ProCrop™ Professional).
- Where a PHI, but no supportive MRL value for South Africa is listed, it indicates that no MRL information was available, and *vice versa*.
