SARS TARIFF DETERMINATION

Please note that the evaluation of the below mentioned application will only commence as from 8 January 2018 as the office for this purpose closed on 15 December 2018.

Governing rules published in terms of Section 47(9) of the Customs and Excise Act, 91 of 1964 ("the Act"), make it compulsory for importers and local manufacturers of ALL alcoholic beverages, including unfortified, fortified and sparkling wines, to submit their product details to the South African Revenue Service ("SARS") for official tariff determination. Importers and local manufacturers must submit their product details to SARS, during the period 1 April 2017 to 31 March 2018, for all product brands for which no tariff determination has previously been issued by SARS.

The following steps should be followed to submit an application on Wine Online (www.dawineonline.co.za):

1. Go to Documentation – Documents – Applications – Compliance Certificate.
2. Click on 'New' to create a new application.
3. Select 'SARS Compliance Certificate' as the certificate type and click on 'Next'.
4. Select the Applicant and click on 'Next'.
5. Click on 'Add Product' or 'Add Another Product' to add a product to the application.
 - 5.1 Search for the product by supplying some of the search criteria and click on 'Next'.
 - 5.2 Select the applicable product and click on 'Next'.
 - If there are 'no records found' and the product has been submitted previously for export and/or SAWIS certification, click on 'Back' and edit the search criteria and follow on from 5.1.
 - If there are 'no records found' and the product has never been submitted for export and/or SAWIS certification, click on 'New' in order to create a new uncertified product. Supply all the applicable information of the product, click on 'Submit' and follow on from 5.2.
 - 5.3 Supply the required information and click on 'Add Product'.
6. If there are more products you want to add to the application, then follow step 5 until all the products have been added to the application. Once this is done, click on 'Next' to continue with the application.
7. For products where no full lab analysis have been found, the system will request a sample. Select the 'New Sample' option of the product and supply the estimated 'Sample Arrival Date'.
 - 7.1 For new products, the system will also request the following documents pertaining to the products to be uploaded:
 - 7.1.1 Ingredients list
 - 7.1.2 Manufacturing Process
 - 7.1.3 Labels
 - 7.1.4 In the case of Cider (Alcoholic Fruit Beverage) an Isotope Analysis Certificate
8. Once all the sample information and the requested documentation has been uploaded, click on 'Next' to continue.
9. Supply the required information pertaining to the collection of the certificate as well as the applicable SARS reference(s) and their confirming document(s). Click on 'Next' to continue.
10. Verify that all the information supplied is correct and click on 'Submit'.
11. Print the confirmation page for reference purposes as well as any lab submissions created.
